Your Official Information Act (1982) request Te Matau a Māui Hawke's Bay Ref: OIA2022064

I refer to your Official Information Act request dated 1 June 2022 where you requested information from Te Whatu Ora – Health New Zealand, Te Matau a Māui Hawke's Bay. Your questions and Te Whatu Ora, Te Matau a Māui Hawke's Bay's response are provided below:

Please could I ask that all the data be broken down year by year, rather than as a total for all the years in question.

- 1. The total number of PGY1 House Officer positions filled by the ACE matching system for each year between 2018 and 2022, and a breakdown of these by country of training of the candidates (e.g. New Zealand, Australia).***

Year	Number of PGY1 House Officer positions filled	Country of training
2018	19	18 in New Zealand. One in Australia
2019	19	All trained in New Zealand
2020	19	All trained in New Zealand
2021	19	All trained in New Zealand
2022	20	All training in New Zealand

- 2. The total number of PGY1 House Officer positions filled in by NZREX graduates for each year between 2018 and 2022.***

Between 2018 and 2020 it is not known how many PGY1 House Officer positions were filled by NZREX graduates. Therefore, this portion of your request is declined under section 18 (g) of the Official Information Act relation to information not held. Te Whatu Ora – Health New Zealand, Te Matau a Māui Hawke's Bay can however confirm that zero PGY1 House Officer positions were filled by NZREX graduates in 2021 and 2022.

Therefore, this portion of your request is declined under section 18 (f) of the Official Information Act relation to substantial collation and research.
