<b>PURPOSE OF THE POSITION</b>	<p>This is a training position. The Intern Pharmacist must always practice under the supervision of a registered practising Pharmacist. The Intern Pharmacist must undertake the Pharmaceutical Society of New Zealand (PSNZ) pre-registration training programme (EVOLVE) and demonstrate competence in all areas of practise prior to registration as a Pharmacist.</p> <p>To provide pharmaceutical care to identified patients in order to achieve the safe, effective and cost-effective use of pharmaceuticals within the limits of resources.</p> <p>To actively partake in the provision/supply of medication through the Hospital Pharmacy dispensary and in the clinical services, taking responsibility for assigned ward/s.</p> <p>To be involved with appropriate service reviews, audits, projects to improve the delivery of the care and patient outcomes at HBDHB.</p> <p>To effectively interact and communicate with medical and nursing staff regarding medication related issues or concerns, supporting compliance to HBDHB guidelines and legal requirements. Provide informal and occasional formal education on relevant topics to maximise patient outcomes.</p>
